About Us

Indian Society for Studies in Cooperation (ISSC): The Indian Society for Studies in Cooperation (ISSC) was established in 1979 with the primary goal of promoting research and studies in cooperation among universities and other institutions working in the area of cooperation, and it is headquartered at VAMNICOM in Pune. It is made up of institutions and individual members working for cooperatives, agriculture, rural development and academics. At present Society have more than 500 members, who are divided into two categories: institutional donors, and individual life members. Every year, Society hosts Annual National Research Conference in various areas of Country to address major topics concerning cooperation and associated areas of socio-economic concerns. Each of these Conferences invites papers on topics chosen for research and deliberations. Society has conducted, organized, and coordinated number of research studies on basic and applied aspects of cooperation.

The Gujarat State Cooperative Union: Established on 19 April 1960 following the bifurcation of Greater Mumbai State, the Gujarat State Cooperative Union has played a pivotal role in advancing cooperative education, training, and development across the state. Drawing inspiration from the legacy of visionary leaders such as Shri Jagjivandas Shivlal Parikh and Shri Madhavalal Bhailalbhai Shah, the Union works in close coordination with 25 District Cooperative Unions. Today, Gujarat is home to over 89,221 cooperative societies, significantly contributing to the socio-economic welfare of its members. A landmark achievement in this journey was the establishment of the Junior Co-operative Training Centre in Bhavnagar in 1958. Under the dynamic leadership of Shri Ghanshyambhai Amin, who has been at the helm since 1993, the vision of establishing a state-of-the-art Cooperative Management Centre, dedicated to the legacy of Shri Vaikunthbhai Mehta was successfully transformed into reality. The Bhavnagar centre now offers a comprehensive 20-week Diploma in Cooperative Management (DCM) and features modern infrastructure, including three fully equipped classrooms, a library, computer lab, conference hall, and hostel facilities accommodating up to 100 students along with a dining area. These facilities make it one of the well-equipped cooperative training centers in Gujarat further reinforcing the states commitment to cooperative excellence.

Cooperative Movement in India

The Cooperative Movement in India, rooted in the ancient philosophy of 'Vasudhaiva Kutumbakam' (the world is one family), has undergone significant transformation since its inception. Initially driven by voluntary efforts, the movement gained legal recognition with the enactment of the Cooperative Credit Societies Act in 1904. Following independence, cooperatives were integrated into national development strategies, with a focus on collaboration with village panchayats to promote rural development and financial inclusion. Institutions such as the National Bank for Agriculture and Rural Development (NABARD) and the National Cooperative Development Corporation (NCDC) have been instrumental in providing financial support and guidance to cooperatives. The establishment of the Ministry of Cooperation in 2021 further reflects the Government's commitment to fostering the growth of cooperatives. Today, cooperatives in India, which operate on principles of prioritizing people over capital, play a crucial role in inclusive economic growth and social empowerment, particularly for marginalized communities. This vast network includes over 8, 00,000 registered cooperative societies with more than 30 crore members, underscoring the significant reach and impact of the cooperative model and in contributing to India's socio-economic development.

Introduction of the Theme

The global cooperative movement has long stood as a model of democratic ownership, economic participation, and community-centered development. In recent years, the challenge posed by climate change, digital divides, socio-economic inequality, and global market disruptions have enhanced the need for more resilient, inclusive, and innovative economic systems. Their resilience is rooted in collective action, where members work together to achieve common goals and build thriving communities. For example, cooperatives have successfully navigated economic disruptions like financial crises and market volatility by leveraging their local knowledge and strong community ties.

With the adoption of the United Nations Sustainable Development Goals (SDGs) and a global push for digital transformation, cooperatives are now reimagining their roles not just as economic entities but as change makers in innovation, climate resilience, and social inclusion. As the world navigates the Fourth Industrial Revolution, characterized by transformative technologies like artificial intelligence, digitalization, and automation, cooperatives offer a model of economic and social empowerment that can ensure sustainable and inclusive growth. Their emphasis on democratic governance and community resilience makes them ideally suited to adapt to technological shifts while maintaining a focus on social equity and environmental sustainability. Thus, integrating cooperatives into global policy discussions is essential for achieving the Sustainable Development Goals (SDGs) and fostering a more equitable and sustainable future.

1. Abstract

The title should be in Times New Roman, 14 Fonts, and Bold. It should broadly include the research question, methodology, likely contribution to the field of knowledge and relevant literature. The full paper should be limited to 6000 words. It should be sent in hard and soft copy.

All submissions must be original and may not be under review by another Publication. Selected papers will be published as book; chapters in an edited book with ISBN number. The full paper should be limited to 6000 words. The paper should be preferably based on the primary data /case studies. Length of papers generally of six to eight pages in A-4size. It should be sent in hard and soft copy.

3. Paper Presentation

The mode of presentation is preferably, offline. Best papers will be felicitated in the next (41th ANRC) conference. There will be no separate registration for paper presentations.
